3. An indicative budget outlining the estimated expenses for realising a major new project. The value of the commission is \$80,000 (plus GST) inclusive of a \$40,000 artist fee and \$40,000 production and project funds (one page)
4. A professional curriculum vitae outlining exhibition history and significant artistic achievements (one page)
5. Examples and links to previous work. Maximum of 10 images/links.
